- (b) Syed Mohammad Baqir Rizvi, Hon'ble MLA and a Member of the Jammu & Kashmir Khadi and Village Industries Board, shall be the Vice-Chairman of the Jammu & Kashmir Khadi and Village Industries Board.

Syed Mohammad Baqir Rizvi, Vice-Chairman of the Jammu & Kashmir Khadi and Village Industries Board, shall have the status of a '**Minister of State**' and shall exercise such of the powers and perform such of the duties of the Chairman, as may be prescribed or as may be delegated to him by the Chairman.
