**Terms & Conditions**

Sale of 15 Tins of mixed flora honey and 7 Tins of Barseem honey (one tin approximately contains 20 to 22 kg honey) produced in the Departmental Beekeeping Centre of the J&K Khadi & Village Industries Board.

1. The honey shall be kept open for spot inspection on 13<sup>th</sup> of September 2018 at Village Hira Chack, P. O Ramgarh, Tehsil Ramgarh District Samba District between 11.00 AM to 04.00 AM and the quality of the honey can be perused at the site.
2. Intending buyers should submit their tenders on the website of the KVIB i.e. [www.jkkvib.nic.in](http://www.jkkvib.nic.in) or Dasti in Divisional Office J&K KVIB Jammu up to 2.00 PM on or before 14.09.2018 .

3. The Earnest Money Deposit @ 10% on the upset price should be remitted by way of Demand Draft /Pay Order drawn on J&K Bank or any Nationalized Bank in favour of the Secretary/CEO, J&K Khadi & Village Industries Board payable at Srinagar. No Bankers cheque or individual cheque shall be acceptable.
4. The tenderer's or their authorized representatives shall remain present at the time of opening the tenders and may participate in the inter-se bidding.
5. Tenders will be opened in the office of the Dy. Chief Executive Officer, KVIB Divisional Office Jammu during the working days between 11.00 AM on 16.08.2018. It shall be open to the bidders to improve their offer in the open court when the inter-se bidding will be conducted. Earnest Money Deposit of the successful bidder shall be retained where as that of other bidders shall be returned to all the bidders.
6. It shall be the sole discretion of the J&K Khadi & Village Industries Board to reject any of the offers without assigning any reasons.
7. If the sale in favour of the highest bidder is confirmed by the committee framed to conduct the bidding process, the highest bidder shall deposit the balance cost price on spot or within the stipulated time.
8. The non-payment of the balance sale consideration after the confirmation of the sale within the period stipulated above shall result in forfeiture of the Earnest Money Deposit and highest bidder shall also be liable in respect of expenses incurred for conducting the sale and other expenses etc.
9. Subject to the confirmation of the sale by the J&K Khadi & Village Industries Board, the bidder shall make arrangement to take delivery of the honey sold to him/her immediately after realization of full sale consideration.
10. The offer once accepted by the J&K Khadi & Village Industries Board shall not be allowed to withdraw.
